Subject: Selection Results of Artists to Participate in the GMS Artist Residency Programme in Chiang Rai Province, under the Mekong River Basin Contemporary Art Festival Project for the Fiscal Year B.E. 2567 (2024)

As per the Office of Contemporary Art and Culture's call for applications for an art exchange programme between Thai artists and artists from the Greater Mekong Subregion (GMS Artist Residency) in Chiang Rai Province, under the Mekong River Basin Contemporary Art Festival Project for the fiscal year B.E. 2567 (2024), outstanding artists who hold nationality of, and currently live and work in, one of the countries in the Greater Mekong Subregion, including Myanmar, Thailand, Laos, Cambodia, Vietnam, and China (only Yunnan and Guangxi provinces) were to be selected to embark on a journey to develop their creative concepts and techniques, as well as to observe the works exhibited at the Thailand Biennale, Chiang Rai 2023, in Chiang Rai Province.
